### Membership Criteria and Levels of Support

Governmental and non-governmental may become Members or Affiliate Members of the Alliance if they:

1. Have a mission consistent with that of the Alliance and agree with the mission of the Alliance; and
2. Provide resources to the Alliance.

Based on consideration of these criteria, the Management Team will determine the acceptance of the entity or organization as a member of the Alliance.

The following are suggested levels of **Membership<sup>1</sup>** support:

Local governments:

\$66 per 1,000 population (based on city or unincorporated county population)

Business associations and non-profit organizations:

\$500 for core budgets of \$99,000 or less  
\$1,000 for core budgets \$100,000 to \$499,999  
\$2,000 for core budgets \$500,000 or more

The following are suggested levels of **Affiliate Membership<sup>2</sup>** support:

\$250 for core budgets of \$99,000 or less  
\$500 for core budgets \$100,000 to \$499,999  
\$1,000 for core budgets \$500,000 or more

**In-Kind Support:** Businesses and non-profit organizations can bring valuable human resources and relationships to this effort. Thus IN-KIND SUPPORT may provide up to 75% of any non-profit's dues and 25% of a business' dues.

**Sponsorship:**

The Alliance will accept additional support from members or affiliate members and will recognize sponsors at the annual meeting and other opportunities as agreed to by the Board of Directors.
